**RELEASE OF LIABILITY**

I/We acknowledge that U.S. Coast Guard approved flotation devices are being provided to me/us and that each person in my/our rental boat is required to wear such devices while boating.

I/We understand that boating is a potentially hazardous activity that involves a risk of injury to any parts of my/our body/ies and that of any other party that I/we may be responsible for. I/We hereby agree to freely and expressly assume and accept the full responsibility for any and all risks of injury or death arising from the use of this boat. I/We hereby authorize any medical treatment deemed necessary in the event of any injury to me/us arising from the use of this boat. I/We either have appropriate insurance or agree to pay all costs of rescue and/or medical services that may be incurred on my/our behalf. I/We understand that the Town of Waterville Valley is not responsible for lost or damaged personal property.

I/We therefore hold harmless, indemnify and release the Town of Waterville Valley, their agents, employees, and volunteers from any and all liability for damages and personal injury resulting from the condition, selection, adjustment or maintenance of this boat, the use of this boat, or the condition of the premises upon which this activity is conducted.

I/We agree to return this rental boat by the time specified by the Dock Attendant. I/We understand that I/We will be responsible for any additional rental fees that may arise from returning this boat late.

I/We agree that there have been no warranties, express or implied, made to me/us relating to this boat rental. I/We agree that any suit or legal action shall be submitted to the jurisdiction of the state or federal courts in the State of New Hampshire and no other jurisdiction. I/We acknowledge that I/We have carefully read this agreement and this "Release of Liability," and I/We understand, agree with, and accept its contents.
